I also acknowledge and accept the following statement: WAIVER OF LIABILITY and ACKNOWLEDGMENT OF ASSUMPTION OF THE RISK. In accordance with section 7-6-22 of the Rhode Island General Laws, entitled "EXEMPTION FROM LIABILITY TO PARTICIPATE IN ATHLETIC SPORTS EVENTS," I hereby release Narragansett Bay Yachting Association (NBYA), its various host organizations in and around Narragansett Bay, including without limitation, Barrington Yacht Club, Bristol Yacht Club, Coasters Harbor Navy Yacht Club, Conanicut Yacht Club, Ida Lewis Yacht Club, Newport Yacht Club, East Greenwich Yacht Club, Saunderstown Yacht Club, Sakonnet Yacht Club, Wickford Yacht Club, West Bay Yacht Club and Sail Newport (collectively the "Host Organizations", and together with NBYA shall be referred to as the "Race Sponsors"), and any and all of the Race Sponsors' officers, directors, trustees, agents, servants, members, volunteers and employees, from any and all claims for negligence, liability, damage, injury, loss, cost or expense, including reasonable attorneys' fees, arising by reason of bodily injury to me or loss of my personal property while I am participating in or practicing for any contest or exhibition of an athletic or sports nature held by the Race Sponsors, and hereby acknowledge and assume the risk of any bodily injury to myself or loss of my personal property while participating in or practicing for any of the Race Sponsors' contests or exhibitions either on the water or on shore. I am aware that the activities may involve maneuvering a boat, sailboard, or other watercraft in deep waters in potentially hazardous conditions which may include, without limitation, cold water temperatures, strong winds and currents, high waves, sudden and unexpected immersion in deep waters and collision with other watercraft or stationary objects such as docks, pilings and buoy's. I have notified my crew of the dangers of participating in regattas and of the details of this wavier of liability. Furthermore I have taken all necessary steps to insure the entered boat is adequately prepared for all possible contingencies, including appropriate safety equipment as may be required by law or that a prudent seaman would consider advisable.
